A WIDE ARRAY OF PROGRAMS AND EVENTS IS OFFERED ON-SITE THROUGHOUT THE YEAR; THESE PROGRAMS AND EVENTS RANGE IN DURATION FROM AN HOUR TO AS LONG AS FIVE DAYS. FOR THE YEAR ENDED JUNE 30, 2015, OVER 300 PUBLIC PROGRAMS WERE OFFERED SERVING OVER 250,000 ATTENDEES, WITH THE VAST MAJORITY PROVIDED AT NO COST TO PARTICIPANTS. THE WRIGHT MUSEUM'S LARGEST ANNUAL PROGRAM, THE THREE-DAY AFRICAN WORLD FESTIVAL, ATTRACTS OVER 150,000 VISITORS FROM THE MIDWEST REGION.
