


THESE PROGRAMS ARE OFFERED ON-SITE THROUGHOUT THE YEAR AND RANGE IN DURATION FROM AN HOUR TO AS LONG AS FIVE DAYS. FOR THE YEAR ENDED JUNE 30, 2014, OVER 100 SUCH PROGRAMS WERE OFFERED, OFTEN AT NO ADDITIONAL CHARGE TO THE VISITORS, AND SERVED OVER 265,000 PARTICIPANTS. THE LARGEST PROGRAM, THE AFRICAN WORLD FESTIVAL, IS A THREE-DAY EVENT WHICH IS HELD ANNUALLY AND ATTRACTS OVER 150,000 VISITORS FROM THE MIDWEST REGION.
